# 2.0 President's Report:

- a. Working on Travel document will send to Tera to send to Reps
  - 1.1.a.1 Christine DW has info for Dave
  - 1.1.a.2 \$70 comes out of travel , \$5 out of department budget
  - 1.1.a.3 Dean has an issue as to whether or not to take car and where reimbursement comes from
  - 1.1.a.4 ECE is putting in at least 100-300 miles a month
    - 1.1.a.4.1 Travel offered to reserve car for them for 2 weeks in the middle of semester and 2 weeks toward end

#### 3.0 Vice President's Report: Fred Loveland

- a. Kudos for Suzanne & Tera with the Organizing Committee
- b. Response to Sullivan Memo
  - 1.1.b.1 We are \$750K in the hole right now, per Michael Sullivan Fred agreed to disagree with Michael Sullivan
    - 1.1.b.2 300 sections had to be slashed in order to balance budget This is the new budgeting methodology
- c. Fast Forward
  - 1.1.c.1 A chairperson has jettisoned FF classes for next Fall because of impact on faculty load
    - 1.1.c.1.1 Department met and voted to stop offering FF
    - 1.1.c.1.2 Chair contacted Fred because Dean and EVP wanted to meet with Chair. Fred intervened to be present for that meeting.
  - 1.1.c.2 Every year, Chairs have to sign a contract to continue or agree to new FF courses
    - 1.1.c.2.1 Contract says there can be no undo pressure put on a chair to offer these courses

- 1.1.c.2.2 Mike Lynch asked if are there other Department Chairs available to be at meeting to show support to Chair on their decision revoking Fast Forward courses?
  - 1.1.c.2.2.1 Chairs to be notified when/where meeting is held so that Administration can see FA support
- 1.1.c.2.3 Fred responded to the request from Fast Forward to put new course offerings on hold until we get a handle on budget and sections
- 1.1.c.2.4 Administration is concerned that if we don't offer the FF, another college will offer them and we lose students. Even if we lost 35% to another college, we still make out better with the 65% coming to campus
- 1.1.c.3 We don't know where Fast Forward money actually is budgeted for once it is in the General Fund
- 1.1.c.4 Rep stated that even if we got the money, that won't help with the load issue
  - 1.1.c.4.1 David Michalak said, that's true but if departments had the money you could justify on campus sections with lower enrollments
- 1.1.c.5 If retrenchment happens, the faculty with FF courses can go to the high schools and monitor the FF classes to make load.
- 1.1.c.6 Department's have the right to decide to accept Fast Forward transfer credit
  - 1.1.c.6.1 Example: English doesn't accept TC3 ENG 111 because it is not a gen ed course
- d. HR Issue Grade of Senior Learning Specialist
  - 1.1.d.1.1 We proposed grade level of 7 since currently no non ranked faculty exist at that level
  - 1.1.d.2 HR changed to level 6 without negotiating or discussing
  - 1.1.d.3 Already approved by BOT and SUNY but still is a possible
  - 1.1.d.4 Grievance or Improper Labor Practice is possible but we will meet with admin again to resolve.

- a. Google Apps
  - 1.1.a.1 If you need help or want training on using Google Drive or Spreadsheets, let Tera know.
    - 1.1.a.1.1 Mike Lynch entered all the info from last year's Freidricks Cards
      - 1.1.a.1.1.1 Rep wanted to know if these could be used as new membership cards
      - 1.1.a.1.1.2 Per Mike Lynch, they are not dues deduction cards, so they can not be used as such. Depending on the wording of the Janus ruling, we may have to get new NYSUT membership forms for everyone again. We won't know until June.
      - 1.1.a.1.1.3 For now, we are focusing on the payroll deduction cards.
