4.0 Vice President's Report: F. Loveland

- 4.1 Professional Math Tutors
 - a. HR has arbitrarily decided what they will be paid based on a hiring date of before or after September 1
 - 4.1.a.1 HR is not using the 2017-18 rate of pay for all tutors hired this academic year. This violates our contract and is being investigated. We have not negotiated a tier system for paying part time faculty.

5.0 President's Report: D. Michalak

5.1 Succession Plan

- 5.1.a.1 Dave is retiring in August, which is about 10 months before the end of his second year of his term. He asked the Reps if anyone was interested in running for the position. As there were no additional volunteers, Dave recommended Howard Streby for the position since he is the only member that expressed interest last year when the initial announcement was made by Dave.
 - 5.1.a.1.1.1 Vote: All approved. Howard accepted and will ask the NRC to select a new chair for that committee

5.2 Negotiations

- a. D. Michalak was approached by F. Battisti about negotiating with just him and K. Drumm and F. Loveland and leave out the BSK law firm.
 - 5.2.a.1 M. Lynch said absolutely. The intent is to get a settlement quickly since that is not in the law firm's best interest. We can lobby for the law firm's money being spent for our proposals. Dr. Drumm will discuss further with the BOT at next week's meeting.

Discussion:

- 5.2.a.1.1 E. Evans why did they change their minds?
 - 5.2.a.1.1.1 J. Spence did they see how organized we are? Speculation on possible motives with Dr. Drum having only 2 years left on his contract, protracted negotiations not in his best interest. Several faculty have asked Dr. Drumm about the anti-union work that the BSK law firm advertises.
- 5.2.a.1.1.1 S. Hickok stated she is not comfortable that an adjunct isn't going to be in the room with administration. Dave reassured Suzanne that all of the faculty is represented and the negotiations team will develop the proposal.
 - 5.2.a.1.1.2 J. Lubar Wants health benefits after 2 semester and 2 classes.
 - 5.2.a.1.1.3 S. Shepard stated The reality is that it is 2-3 people in a room who get things done
 - 5.2.a.1.1.4 Fred never seen it happen any other way than this.
 - 5.2.a.1.1.5

 A. Caroompas stated that If it wasn't for the FT people/leaders in the room now, the PT faculty wouldn't be here now We (all members, including Part Time Faculty) elected Dave and Fred to represent us in the last election, so we are all represented.
- 5.2.a.1.1.5.1.1 J. Lubar: Why won't the BOT give PT health insurance?

 Dave The number of PT faculty would cost the college at least 1.5 million dollars at the current rates.
