- 3.2 Rep Council Elections

- 3.3 Online Course Evaluation Tool (SurveyDIG) as an option for Face to Face class evaluations
 - a. Recommendation coming out of Shared Governance CAI
 - b. Dave proposes that a committee is formed to look at the survey to see if it needs to be modified or if we can take the face to face form and put it online
 - 3.3.b.1 Suzanne S asked why do they want this now?

4.0 Vice President's Report: D. Michalak for F. Loveland

- 4.1 Faculty Member has been put on administrative leave
 - a. As procedure, the faculty member has their salary maintained and everything else (benefits, etc).
 - 4.1.a.1 If someone is teaching extra, like the summer, and this leave continued through the summer, and those classes run, that person would get paid even if they're on leave.
 - b. Brian L what is the standard to make admin do that?
 - 4.1.b.1.1 In general, the litmus test is whether the person is some kind of threat. That's one criteria.

 Another is if there is a complaint. Recently, it was a title nine complaint that prompted a leave of absence with pay. Legally, a person has to be held harmless when it comes to salary and benefits. That's why we discuss this with the administration as a follow-up.
 - 4.1.b.2 Brian L is it the law? Yes, the Taylor Law is followed. If discipline/ removal was involved our contract must be followed and becomes the legal procedure.
 - 4.1.b.3 Article 45 No one shall be removed from class without due process, meeting with chair, dean, and grievance VP.
 - 4.1.b.3.1 We enforced the contract that was violated, but this does not change the outcome in this case.

- 4.1.b.3.1.1 The Administration was put on notice for future incidents.
- 4.1.b.4 Ed was there any explanation in the meeting that was held about the nature of why they did what they did. Dave only in the terms of the complaint. No details.
 - 4.1.b.4.1 Brian how long can they do this? Dave the college will have to decide what action will be taken. If they decide to press a formal charge, Article 45 will be followed. That hasn't happened yet
- 4.1.b.5 Ed Theoretically, Title nine, isn't there a provision on answering in a timely manner? Dave Don't know if 'timely fashion' is defined
- 4.1.b.6 Joe We won't know, they could take as long as they want
- 4.1.b.7 Suzanne S This is ironic, considering what happened to Tred. It took 2-3 years
- c. Dave Admin has to make a decision where to move this, if they want someone fired, it becomes a legal case. It's an arbitration hearing with a judge whose decision is binding.
 - 4.1.c.1 Ed is this a strategic hit? Dave we don't know Suzanne If it was calculated, it was a miscalculation of the strength of the union. If they are up to something, it's going to fail.
